- a. Hiring interpreters under RID moratorium There is a backlog of testing from RID. Valencia added EIPA (Educational Interpreter Performance Assessment) to pay scale at Level IV. If assessed and a 4 is received then interpreter can get a National Certification from RID.
- b. SB 850 and possible speaker-Senate Bill 850 allows students that were previously issued a "Special Diploma" access to postsecondary education with Access diploma. Considering asking someone from the DOE or transition, probably Alex Jordan or Federico Valadez to discuss this issue.
- c) Underprepared students- Increased number of students are entering college with Access diplomas due to SB850, but are not prepared for postsecondary education. Students with Intellectual Disability diagnosis are the majority of the challenges. Students are registering for classes, taking out aid, but failing their classes. We are currently researching GAP year options for families within the State as an alternative to assist the students not faring well.
